THE INDUSTRIAL AND PROVIDENT SOCIETIES ACT

The Industrial and Provident Societies (Amendment) Regulations, 2015

In exercise of the power conferred upon the Minister by section 64(2) of the Industrial and Provident Societies Act, and of every other power hereunto enabling, the following Regulations are hereby made: -

- 1. These Regulations may be cited as the Industrial and Provident Societies

 (Amendment) Regulations, 2015, and shall be read and construed as one with the

 Industrial and Provident Societies Regulations, 1903 (hereinafter referred to as the

 "principal Regulations"), and all amendments thereto.
- 2. The principal Regulations are amended by inserting, next after the heading "Cancellation and Suspension of Registry" appearing after regulation 6, the following regulation
 - "6A. For the purposes of section 8 of the Act
 - (a) "capital base" means the total amount of shareholder's equity

 (including deferred or permanent shares, reserve fund, retained surplus
 and any other eligible reserves, as determined by the Registrar) less
 any amount by which that total has become impaired by operating or
 other losses; and
 - (b) "prescribed liabilities" means liabilities that the Minister may specify by notice, upon the recommendation of the Registrar, from time to time.".
- 3. The principal Regulations are amended by inserting next after regulation 36 the following heading and regulation –

Banking by Societies

36A. For the purposes of section 18(4) of the Act, the prescribed amount is ten

thousand dollars.".

- 4. The principal Regulations are amended by inserting next after the heading "Dissolution" the following regulation
 - 36B. Every application for dissolution made under section
 Form AG1.
 53(b) of the Act shall be in the form set out as Form AG1 and shall be signed in duplicate and accompanied by an application fee of five thousand dollars.".
- 5. Regulation 37 of the principal Regulations is amended by deleting the words "two thousand five hundred dollars" and substituting therefor the words "five thousand dollars".
- 6. The principal Regulations are amended by deleting regulation 43A and substituting therefor the following
 - "43A. In *lieu* of the provisions of the Third Schedule to the Act, the following scale of fees shall have effect –

Description of Registered Society	Annual Fee Payable
Where the aggregate value of the assets exceeds \$15,000 but does not exceed \$50,000	\$500.00
Where the aggregate value of the assets exceeds \$50,000 but does not exceed \$100,000	\$1,000.00
Where the aggregate value of the assets exceeds \$100,000 but does not exceed \$500,000	\$3,000.00
Where the aggregate value of the assets exceeds \$500,000 but does not exceed \$1,000,000	\$5,000.00
Where the aggregate value of the assets exceeds \$1,000,000 but does not exceed \$5,000,000	\$8,000.00

Where the aggregate value of the assets exceeds \$5,000,000 but does not exceed \$10,000,000	\$12,000.00
Where the aggregate value of the assets exceeds \$10,000,000	\$15,000.00.".

7. The principal Regulations are amended in the manner indicated in the second column of the Schedule, in respect of the matters specified in relation thereto in the first column of the Schedule.
